7. Membership Validation

Following the latest UKARA refusal to offer UKAPU a verification login to the data base and frequent complaints from applicants arising from poor verification responses from playing sites, it has become obvious that the requirement for UKAPU members to be checked against the data base and validated as skirmishers is difficult to manage and introduces detrimental delays into the membership process. Full verification is probably not necessary for our purposes.

It is proposed that members self validate on application. This would entail a check box type answer to a statement on application that they are a skirmisher. This would be reinforced by a restating of the position that UKAPU membership does NOT confirm a defense to purchase RIF or IF.

It was also proposed that an annual renewal date for all members be introduced with a scale of charges for members joining close to the renewal date.
